Remarks

The provisions of the currently Corona Protection Ordinance applicable in Saxony. Instructions and regulations must be observed.

- 3G Rule: Judges/ Coaches/ Trainers/ Helpers from 17 years of age

- negative test proof: Sars-CoV2-Ag test valid for 24 hours

Self-test possible on site under supervision (test must be brought along)

- Compulsory school test for children under the age of 18: no proof required

- Children up to the age of 6 and children who have not yet started school, are not subject to testing

- Supervisor key (includes coaches, drivers, parents etc.; not judges):

- 1. Athletes: 1 supervisor

- from 4 athletes: 2 supervisors

- from 8 athletes applies: 1 supervisor for every 4 athletes

- Only people without typical symptoms that indicate a SARS-CoV-2 infection are allowed to use the attend event

- Obligation to wear the prescribed medical mouth and nose protection in Indoor areas (excluding athletes in battle)
