It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the possibility, but no obligation, to give the name.							
Medical	A doctor is present in the competition site. Only doctors are entitled according to the international statutes to grant medical breaks during the fights. PLEASE NOTE THE CORONA RULES Due to the currently ongoing Corona pandemic, the official Corona rules at the venue must be observed. There is a possibility that due to regional regulations no spectators and only limited attendants can be admitted and that only persons who are vaccinated or recovered can be admitted. All participants are obliged to follow and observe even last-minute changes. No claim for damages against the DFB can be derived from the fact that an athlete or other participant cannot take part due to the Corona regulations applicable on site. Should stricter regulations apply by the authorities, the state regulations shall take precedence.
