LICENSES AND REGULATIONS

- . The tournament will proceed in accordance with FIE regulations.
- . Individual events will proceed in accordance with the regulations applicable to their respective categories i.e. (National Circuit and the Federation Trophy). However, the organizers reserve the right to choose the most adequate procedures based on the number of participants.
- . Participants must be in possession of a national or international license valid for the dates of the tournament.
- . The organizers decline all responsibility in case of accident or lost/stolen property.
- . City shoes or high-heeled shoes are forbidden in the sports halls. Only non-marking soles are permitted. We ask that you leave all other types of shoes at the hall entrance Pets are forbidden in the sport hall.

REFEREEING

- . Clubs registering 3 participants for the same weapon or 5 participants for the day are asked to provide one referee to the tournament organizers or to pay a fine of 150€. Starting with the 9th participant, the clubs will provide two referees to the tournament organizers. The fine for not providing additional referees is fixed at 75€ per missing referee, beyond the first required referee. In the case a participating club does not pay the fines, the organizing club will ask the participating club members to pay the fine before participating in the tournament via bank transfer (payable to Cercle d'Escrime de Neufchâteau, account number at Fortis: IBAN BE21 0016 8246 5303; BIC: GEBABEBB au nom du CEN ASBL
- . All tournament referees must be licensed, qualified and officially recognized.
- . In case of need, self-refereeing is allowed (only in the pools) in the junior-senior categories as long as it is done by licensed referees and officially recognized.
- . The referees are at the disposition of the Technical Direction all throughout the day, starting with the first match that one of his or her club participates in, and cannot leave the tournament without having received authorization from the tournament's Technical Direction
- . Any referee named by his or her club at the time of registration (or after registration) must present him or herself to the tournament organizers the day of the tournament. Except if the club un-registers its participants for Thursday, September, 7, 2017 at 13:00 at the latest. Otherwise, the rules for missing referees will be applied.

ORTRUN MORAIS CHALLENGE Generalities

The Fencing Circle of Neufchâteau created this challenge in honour of Mrs. Ortrun-Morais and her passion for fencing. She was president of our circle from 1990 to 2005. We wish to thank her family for allowing us to organize this challenge.

Article I

The Ortrun-Morais Challenge is to be held during the International Tournament in Neufchâteau. Our tournament is organized each year. Traditionally, it is held on the third weekend of September at the Centre de Lac in Neufchâteau (Belgium).

Article II

The Ortrun-Morais Challenge rewards the four following categories:

Epee, Senior Women- Epee, Senior Men-Foil, Senior Women - Foil, Senior Men

The challenge is open to all fencers, men and women, from the world over who are in possession of a valid license issued by their respective national or international federation or organizing body. Presentation of said license is obligatory.

Article III

A trophy, represented by a historical reproduction epee or foil, is to be won in each category. The trophy will stay in the possession of the organizer unless all the conditions of article 4 are fulfilled.

Article IV

The fencer having won three Challenges within a maximum of 5 years at our international tournament will be able to keep the trophy corresponding to his or her category.

Article V

After having taken possession of the trophy in accordance with article IV, the athlete in question will see his or her victory count at zero for the next year's tournament.

Article VI

In case of disagreement, the governing body of the Fencing Circle of Neufchâteau is the only body authorized to decide the dispute.
