The referees officiating at EFC U23 circuit should have DFB CN licence and an annual licence, good national or international level qualification and be aged minimum 18 and less than 60.

This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. fights.
