Adolescents under the age of 18 need a health certificate (not older than 365 days). It is not permitted to participate on multiple competitions per competition day. Only one entry per athlete for each category is allowed.
<b>Quota</b>	The order of the incoming entries decides about the participation. 16 per tournament
<b>Referees</b>	Referees are not required. Athletes may have to judge each other
