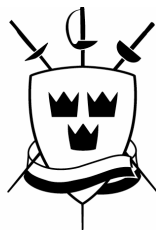
Registration fee

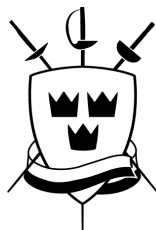
Equipment

The fencers must have equipment in accordance with FIE's decisions (FIE blades, mask 1600 N, fencing dress and plastron 800 N). Fencers equipment shall be controlled and approved by the equipment control before the start of the competition. FIE blades are not required in the Cadets Tournament.

Doping control (only applicable for the JWC competition)

Doping control will be effectuated according to the rules of the FIE.

Quota of referees

The Federations must bring referees at least in accordance with the FIE regulations:

1 - 4 fencers = 0 referee, 5 - 9 fencers = 1 referee, 10 fencers or more = 2 referees.

Federations not bringing referees at least in accordance with the quota, will be liable to pay a fine of € 1 000 (CHF 1 500) to the organizing committee. The fine shall be paid when the fencers from the Federation are registered. If the Federation informs the organizing committee at least 15 days before the competition that the Federation will not fulfil its quota of referees, the fine will be reduced to € 500 (CHF 750).
