Remarks	Corona protection measure: A hygiene concept is available. G2. Vaccinated fencers do not need to bring a test certificate with them. Schoolchildren must all bring a qualified self-assessment (such as school certificate), which can be found on the HFCL website: https://www.fechten-hl.de/ Unvaccinated athletes up to the age of 18 must present a current negative test certificate that is not older than 24 hours. People who cannot be vaccinated for medical reasons and who can prove this with a medical certificate. You must present a recent negative test evidence that is no older than 24 hours. There is no limit to the number of participants. For every four fencers: one coach is allowed into the hall. Number of spectators: only allowed up to 50 people - please register the spectators! Spectators stay on the balustrade, G2, mask requirement, distance rules should be observed. The buffet is accessible for spectators and athletes. In the interior, the owner of the domiciliary rights or persons authorized by him or her who are allowed to use the sports facility are only allowed to do sports within the meaning of the 2G rule, provided that the sportsmen do not have any corona-typical symptoms (shortness of breath, new coughing, fever, loss of smell or taste).
