**ENTRY:** The World Cup is open to all fencers with a 2016-2017 FIE licence. Participation in this competition is subject to art. o.54 of the FIE Organisation Rules.

Entries being closed at the deadlines mentioned in the article (o.54.2), **the competition organiser must establish the list of the exempted fencers and the pools according to art. o.31.2 and o.31.3 of the FIE Rules.**

No changes can be made concerning the 16 exempted fencers whose nomination had already been communicated.

***The list of attending fencers is the list downloaded latest at 3 pm the day before the competition, according to art. o.31.2 of the Organisation Rules.***

***The pools will immediately be sent to the FIE to be published on the website [www.fie.org](http://www.fie.org).***

**FORMAT:** The matches take place according to the FIE Rules. An information kit for delegations will be published on the website of the organiser [www.hunfencing.hu](http://www.hunfencing.hu) and of the FIE [www.fie.org](http://www.fie.org) latest one month before the beginning of the competition.

**REFEREES:** The costs of the referees, who will be designated by the FIE, shall be borne by the Organising Committee. Delegations do not have to bring referees.

**TECHNICAL RULES:** According to the FIE Rules in effect (**t.17.2**) the Referee places each of the two competitors in such a way that the back foot of each is 2 m from the centre line of the piste (that is, in front of the "on-guard" lines).

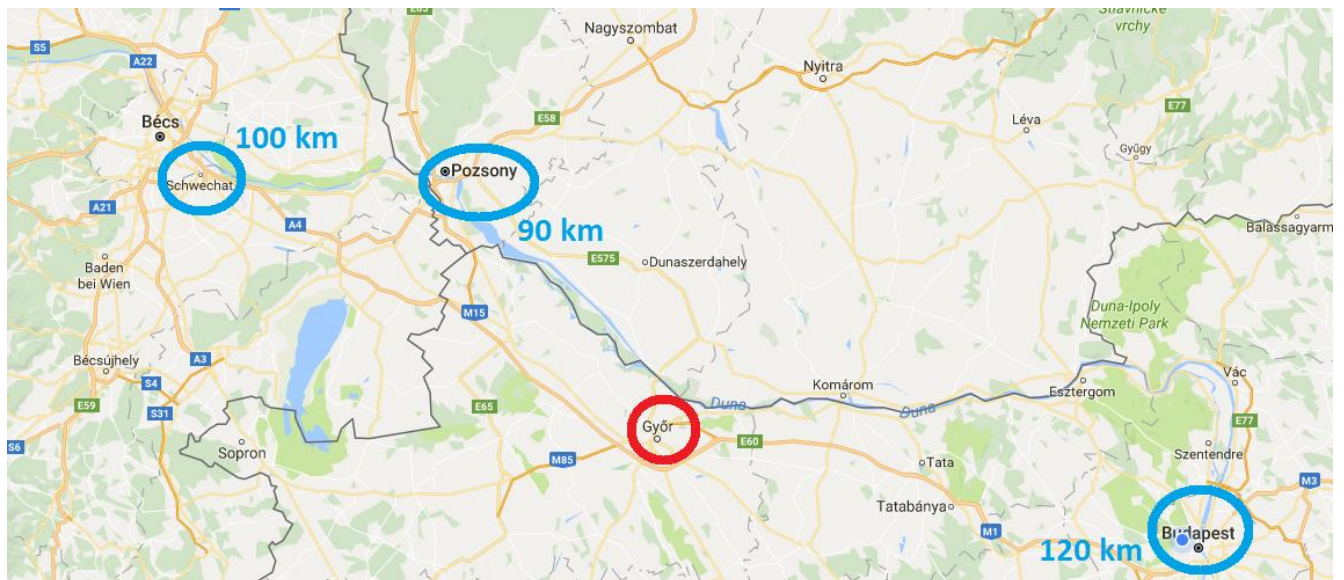
