Participation

Each national federation may enter a maximum of 12 fencers. The organising country may enter up to 20 fencers plus the number needed to make up the pools.

Entry

Open to all fencers with valid 2022-2023 FIE License.

No fencer is allowed to take part in an official event of the FIE unless he or she is at least 13 years old on 1 January in the year of the competition.

Entries of fencers, teams and referees can only be made at the FIE website, www.fie.org, respecting the deadlines specified in the FIE Rules (cf. o.54).

ENTRY FEE:

An entry fee of € 100 per fencer will be given to the organiser until 17:00 on 16th March at the desk in the venue.

Referee Obligation

The referees are designated by the FIE and delegations will not have to provide any referees.



Formula

The competition formula will be as per FIE rules.

One qualifying round of pools, a preliminary direct elimination table, a main direct elimination table of 64 fencers to qualify for a final by direct elimination. For your information about the competition, please check FIE Website and KFF website (<http://fencing.sports.or.kr>)

Doping

Doping control will be done according to FIE rules.

TRANSPORTATION

Our organizing committee and agency will provide transportation service as below to only the participants who will stay at our official hotels:

1. Incheon Airport(ICN) <-> Gimpo Airport(GMP)

If taking the flight to Busan Gimhae Airport(PUS) from Gimpo Airport(GMP) after arriving at Incheon Airport(ICN), the organizing committee and agency will provide the transportation shuttle service between Incheon Airport(ICN) <-> Gimpo Airport(GMP).

The bus transportation time between Incheon Airport and Gimpo Airport is about 60 minutes, so please book the flight ticket (Gimpo <-> Gimhae) considering the local traffic situation. Also, please consider the time of arrival procedures at Incheon Airport and departure procedures at Gimpo Airport.

<Bus Stop>

Terminal 1 Bus stop location (1st Floor Platform No.6)

- After arrival, use exit C and take the bus at No.6

Terminal 2 Bus stop location (Transportation center B1 floor Platform No. 24, 25)

- After arrival, go to transportation center on B1 and take the bus at No.24 and 25

2. Busan Gimhae Airport(PUS) <-> official hotel (Bus)

After arriving at Gimhae Airport(PUS) in which route, the organizing committee and agency will provide the transportation shuttle service between Busan Gimhae Airport(PUS) <-> official hotel.

3. Official Hotel <-> Venue

The distance between the official hotel and the venue is 20 minutes distance by car. Transportation service for will be provided by the Organizing Committee.

COVID-19 Outline for the season 2022-2023(FIE)

Covid-19 plan for the 2022-2023 season The sanitary measures at FIE competitions have been adapted as follows, until further notice: - Wearing a sanitary mask is no longer compulsory, but remains recommended; - Participants will have to present to the organisers the negative result of a Covid-19 test (PCR or Rapid Antigen Test), carried out within a maximum of 72 hours before arrival in the country. Other sanitary measures at the competition may be implemented by the host federation at their option or as required by the national authorities. However, in case the covid-19 situation would worsen, the sanitary measures will be revised accordingly and federations will be informed immediately.



COVID-19 outline of overseas arrivals

The current entry rules for Korea are as follows. As soon as the regulations are relaxed or changed, KFF will send updated covid-19 regulations to FIE and all World fencing families.

◆ Obligatory use of Q-CODE by arrivals from China ('23.1.2. 00:00 ~ (based on arrival time))

- Input quarantine information in Q-CODE and complete issuance of QR Code prior to boarding plane

◆ Obligatory screening prior to arrival for those coming from China ('23.1.5. 00:00~)

- Must bring PCR Negative Confirmation Certificate for screening conducted within 48 hours or RAT Negative Confirmation Certificate for specialists for screening conducted within 24 hours with 00:00 of the date of departure as the reference (those without such certificate won't be allowed to board the plane)

◆ Obligatory PCR screening within 1 day of arrival for those coming from China ('23.1.2. 00:00~)

- Upon entry, register the screening results in Q-CODE website after having completed PCR screening within 1 day of arrival (within the date immediately after the date of arrival)

* Access Q-CODE website (cov19ent.kdca.go.kr) → Select 'Register screening after arrival'

**** Athletes departing from China, Hong Kong, and Macau must check the regulations at the local Korean embassy.**



Visa

All the incomers from outside of Korea must apply for **K-ETA** in advance. You can easily apply K-ETA via website.
