Whoever does not present this certificate cannot start".  !!! ATTENTION !!! --> Referees are to be registered per athlete/club <--.  Access is only allowed for accredited persons (fencers, coaches, officials, attendants, helpers of the organiser). These must also be registered via the Ophardt registration system or by e-mail. We will check the registrations before entering the competition site. We kindly ask you to arrive in good time and to be prepared. In case of waiting in front of the control station, please observe the minimum distance of 1.5 m. We ask everyone for understanding and acceptance, if necessary there may be delays and a late start of the competition is possible. Attendance will be documented.  Masks are compulsory in the sports hall. Masks do not have to be worn during the warm-up, during the fights and at your own place.
