- License: All under 23-year fencers need EFC-CEE Licence (15 €) to be provided by relevant national federation office.
- Entry fee: **25 € will be collected by bank transfer receipt until February 18th, 2020. or cash before tournament on tournament's day.**

The referees officiating at EFC U23 Circuit should have DFB Cn licence, good national or international level qualification and be aged minimum 18 and less than 60.

The referees will get free accommodation in the Alecsa Hotel (if applied) and a daily allowance of 50 € per employed day.

Missing referee's costs 500 € per referee.

Equipment: Equipment and weapons must agree with the rules of the FIE. Transparent masks are forbidden. The registration of the name on the fencing jacket is mandatory.

Responsibility: All fencers and referees participate in the tournament on their own risk and are responsible for their equipment by self.

Juristic: By participation in the tournament fencers accept the jurisdiction of the German Fencing Federation

Prices: The winner gets a KPM Porcelain polar bear. All finalists will receive memory-prizes. The best 8 fencers get cash prizes in total of 4750 Euro.

Doping: Doping control will be conducted at the end of the tournament.
