**Entries:** Quota in accordance with the FIE rules. Entries via the FIE website. A valid 2016/2017 season FIE license is obligatory.

**Entry fee:**

- **60 EUR/fencer** for individual competition (to be paid at the 20<sup>th</sup> October 15:00 h – 20:00 or 21<sup>st</sup> October 07:30 h – 08:30 h)
- **400 EUR/team** for team competition (to be paid at October 22<sup>nd</sup> **10:00 h – 12:00 h**).

**Anti-doping Control:** Anti-doping Control according to the rules of the FIE.
