REGULATIONS: FIE regulations apply - FIE equipment and tournament format  
FIE regulations require that fencers must be registered with the FIE for the  
2004-2005 FIE License; otherwise fencer will not be allowed to compete.

REFEREES: Foreign delegations with 5-9 fencers must bring 1 FIE rated referee;  
If a delegation has more than 9 fencers, then 2 FIE rated referees must be  
provided. If a country cannot provide the required number of referees, that  
country must notify the USFA two weeks prior and pay \$500 (USD) for each  
missing referee. If the country does not notify the USFA and participates  
without the required number of referees, the FIE will fine that federation  
1,000 euros for each missing referee.
