5. “Bubble system”

- Main principle is that every team lives separately between arrival and end of tournament.
- Each team will receive a separate part of hotel including “dining room” and “own” place at the venue.

- Medical testing point will be organized on campus. Participants ‘ll be tested upon arrival to the campus.
- **Arriving by public transport with valid no more than 72 hours PCR test**
